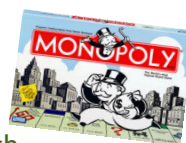

News from Indian Country: Three from 2013

This month's article will describe three 2013 news stories that impacted Native American communities.

As I've done with previous articles, each story will include a summary and web links for readers to learn more, if they so desire. I had thought of calling this article *The Best of 2013*, but it is more appropriate to title it *Three from 2013*.

These are stories that have been discussed for more than a year which address subjects (adoption of Native children, budget cuts to Indian programs, and honoring Native military veterans) that will continue to be discussed for a long time.

In 2009, a couple from South Carolina sought to adopt a child whose father, Dusten Brown, was an enrolled member of the Cherokee Nation and whose non-tribal mother had custody of the child per an agreement with Brown. Brown contested the adoption on the grounds that he was not properly notified in accordance with the federal Indian Child Welfare Act. He received custody of his daughter after winning cases in trial court and the South Carolina Supreme Court.

The case received extensive coverage in the national media, and spurred calls for Congress to review and make amendments to the 1978 Indian Child Welfare Act. Reflecting the intention of ICWA, the case also created discussion over why Native children, when parents are unable to care for them, should remain with other family members or other members of their Tribe. The case also spawned

debate over the custodial rights of a parent who previously gave up those rights.

In October 2012, the adoptive couple petitioned the Supreme Court of the United States to review the case. In January 2013, the court granted a review of the case and heard it in April. In June, the Supreme Court issued a 5-4 decision, holding that a non-custodial father did not have rights under the ICWA, and sent the case back to the South Carolina courts for further hearings on the issue. In July 2013, the South Carolina trial court finalized the adoption of the child to the adoptive couple, but this was prohibited in August by the Oklahoma Supreme Court. The stay was lifted in September 2013, and the child was turned over to her adoptive parents the same month.

You may or may not have noticed the effect federal budget sequestration had on federal Indian programs, but many people were writing and talking about it including many journalists who work for Native American owned publications. Sequestration refers to the across the board spending cuts that took place early last year. The FY 2013 sequestration began when Congress' Joint Select Committee on Deficit Reduction failed to develop a framework call for in the Budget Control Act of 2011 to reduce the nation's deficit by \$1.2 trillion.

While many federal programs were

impacted by the budget cuts, the cuts on federal Indian programs appear to have had a more direct impact on tribal communities with over \$500 million in program cuts. This included \$220 million cut to the Indian Health Service, \$33 million to the Native American Housing Block Grant, and \$12 million to Indian Head Start programs. There are some indications that the 2014 budget will include funding that will make up some of the cuts made in these programs. More so, the fight for federal budget dollars is ongoing.

On December 27, 2013 President Obama signed H.R. 2219, the Native American Veterans' Memorial Act of 2013. This Bill authorizes the construction of a new National Native American Veterans' Memorial on the property of the National Museum of the American Indian located at the National Mall in Washington D.C., along with several other museums and national monuments. There is a memorial for Native veterans now, but it is located inside the museum.

The signing of this Bill was a milestone in an ongoing effort to have a public site dedicated to Native American veterans. Native American veterans have been honored many times in many ways; I don't think anyone has questioned their service, but with all the memorials located at the National Mall, there is not one that recognizes the contributions of Native veterans (42,000 Native Americans served in Vietnam).

New \$9.84 Scam as Reported by the BBB



The Better Business Bureau is warning consumers ... be aware of a new credit card scam circulating where a recent charge of \$9.84 appears on your credit card statement from an unfamiliar website. Scammers are charging stolen credit card numbers a small amount of money in hopes cardholders will not notice the small charge and credit card companies won't go after the minor charge.



Check your credit card statements carefully. If you notice ANY unauthorized charges, promptly report the charges to your bank and request a new credit card. At this point, your credit card has been compromised and it is likely the scammers will charge again.

Don't Be A Victim - Warning Signs of ID Theft

Identity theft occurs when someone uses your name, Social Security number, date of birth, or other identifying information, without permission, to commit fraud. Protect yourself, protect your money, and be aware of the warning signs of ID theft. If you spot a problem early, it is easier to remedy.

RED FLAG WARNINGS

1. You receive a bill for a purchase you did not make.
2. There are unauthorized charges on your monthly credit card statement.
3. You receive collection calls for goods or services you did not purchase.
4. You receive new credit cards or statements for accounts that you didn't open.
5. You don't receive your regular monthly bank or credit card statement in the mail (or email) as usual.
Someone may have changed your mailing address with your financial institution so fraudulent activity is not immediately detectible.
6. You receive an email acknowledging your change of address request WHICH YOU DID NOT MAKE.
7. You receive denials of credit for no apparent reason, e.g. a credit card or loan you did not apply for.

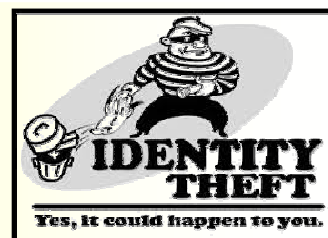
Follow up on ANYTHING that looks or feels out of the ordinary. ID thieves are skilled and cunning at their trade and expect complacency from their victims. **Do not be a victim.**

You may request your FREE credit reports annually from EQUIFAX, Experian, and TransUnion. **Be vigilant about checking your credit reports annually, or better yet, quarterly.** If you check one credit report per quarter, you have a better chance at identifying any fraudulent activity than if you check all three credit reports once annually.

To receive your FREE credit report(s), log on to: www.annualcreditreport.com

Go over your credit report thoroughly and **investigate any inaccurate activity or information, such as accounts or addresses.** Each credit report provides contact information and instructions on what to do if you think you may be a victim of identity theft.

News from Indian Country: Three from 2013

This month's article will describe three 2013 news stories that impacted Native American communities.

As I've done with previous articles, each story will include a summary and web links for readers to learn more, if they so desire. I had thought of calling this article *The Best of 2013*, but it is more appropriate to title it *Three from 2013*.

These are stories that have been discussed for more than a year which address subjects (adoption of Native children, budget cuts to Indian programs, and honoring Native military veterans) that will continue to be discussed for a long time.

In 2009, a couple from South Carolina sought to adopt a child whose father, Dusten Brown, was an enrolled member of the Cherokee Nation and whose non-tribal mother had custody of the child per an agreement with Brown. Brown contested the adoption on the grounds that he was not properly notified in accordance with the federal Indian Child Welfare Act. He received custody of his daughter after winning cases in trial court and the South Carolina Supreme Court.

The case received extensive coverage in the national media, and spurred calls for Congress to review and make amendments to the 1978 Indian Child Welfare Act. Reflecting the intention of ICWA, the case also created discussion over why Native children, when parents are unable to care for them, should remain with other family members or other members of their Tribe. The case also spawned

debate over the custodial rights of a parent who previously gave up those rights.

In October 2012, the adoptive couple petitioned the Supreme Court of the United States to review the case. In January 2013, the court granted a review of the case and heard it in April. In June, the Supreme Court issued a 5-4 decision, holding that a non-custodial father did not have rights under the ICWA, and sent the case back to the South Carolina courts for further hearings on the issue. In July 2013, the South Carolina trial court finalized the adoption of the child to the adoptive couple, but this was prohibited in August by the Oklahoma Supreme Court. The stay was lifted in September 2013, and the child was turned over to her adoptive parents the same month.

You may or may not have noticed the effect federal budget sequestration had on federal Indian programs, but many people were writing and talking about it including many journalists who work for Native American owned publications. Sequestration refers to the across the board spending cuts that took place early last year. The FY 2013 sequestration began when Congress' Joint Select Committee on Deficit Reduction failed to develop a framework call for in the Budget Control Act of 2011 to reduce the nation's deficit by \$1.2 trillion.

While many federal programs were

impacted by the budget cuts, the cuts on federal Indian programs appear to have had a more direct impact on tribal communities with over \$500 million in program cuts. This included \$220 million cut to the Indian Health Service, \$33 million to the Native American Housing Block Grant, and \$12 million to Indian Head Start programs. There are some indications that the 2014 budget will include funding that will make up some of the cuts made in these programs. More so, the fight for federal budget dollars is ongoing.

On December 27, 2013 President Obama signed H.R. 2219, the Native American Veterans' Memorial Act of 2013. This Bill authorizes the construction of a new National Native American Veterans' Memorial on the property of the National Museum of the American Indian located at the National Mall in Washington D.C., along with several other museums and national monuments. There is a memorial for Native veterans now, but it is located inside the museum.

The signing of this Bill was a milestone in an ongoing effort to have a public site dedicated to Native American veterans. Native American veterans have been honored many times in many ways; I don't think anyone has questioned their service, but with all the memorials located at the National Mall, there is not one that recognizes the contributions of Native veterans (42,000 Native Americans served in Vietnam).

New \$9.84 Scam as Reported by the BBB



The Better Business Bureau is warning consumers ... be aware of a new credit card scam circulating where a recent charge of \$9.84 appears on your credit card statement from an unfamiliar website. Scammers are charging stolen credit card numbers a small amount of money in hopes cardholders will not notice the small charge and credit card companies won't go after the minor charge.



Check your credit card statements carefully. If you notice ANY unauthorized charges, promptly report the charges to your bank and request a new credit card. At this point, your credit card has been compromised and it is likely the scammers will charge again.

Identity theft occurs when someone uses your name, Social Security number, date of birth, or other identifying information, without permission, to commit fraud. Protect yourself, protect your money, and be aware of the warning signs of ID theft. If you spot a problem early, it is easier to remedy.

RED FLAG WARNINGS

1. You receive a bill for a purchase you did not make.
2. There are unauthorized charges on your monthly credit card statement.
3. You receive collection calls for goods or services you did not purchase.
4. You receive new credit cards or statements for accounts that you didn't open.
5. You don't receive your regular monthly bank or credit card statement in the mail (or email) as usual.
Someone may have changed your mailing address with your financial institution so fraudulent activity is not immediately detectible.
6. You receive an email acknowledging your change of address request WHICH YOU DID NOT MAKE.
7. You receive denials of credit for no apparent reason, e.g. a credit card or loan you did not apply for.

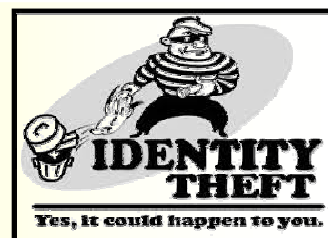
Follow up on ANYTHING that looks or feels out of the ordinary. ID thieves are skilled and cunning at their trade and expect complacency from their victims. **Do not be a victim.**

You may request your FREE credit reports annually from EQUIFAX, Experian, and TransUnion. **Be vigilant about checking your credit reports annually, or better yet, quarterly.** If you check one credit report per quarter, you have a better chance at identifying any fraudulent activity than if you check all three credit reports once annually.

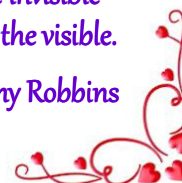

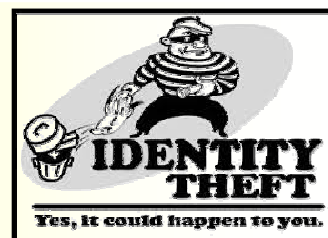

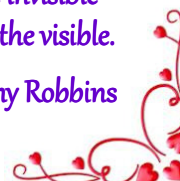

News from Indian Country: Three from 2013

This month's article will describe three 2013 news stories that impacted Native American communities.

As I've done with previous articles, each story will include a summary and web links for readers to learn more, if they so desire. I had thought of calling this article *The Best of 2013*, but it is more appropriate to title it *Three from 2013*.

These are stories that have been discussed for more than a year which address subjects (adoption of Native children, budget cuts to Indian programs, and honoring Native military veterans) that will continue to be discussed for a long time.

In 2009, a couple from South Carolina sought to adopt a child whose father, Dusten Brown, was an enrolled member of the Cherokee Nation and whose non-tribal mother had custody of the child per an agreement with Brown. Brown contested the adoption on the grounds that he was not properly notified in accordance with the federal Indian Child Welfare Act. He received custody of his daughter after winning cases in trial court and the South Carolina Supreme Court.

The case received extensive coverage in the national media, and spurred calls for Congress to review and make amendments to the 1978 Indian Child Welfare Act. Reflecting the intention of ICWA, the case also created discussion over why Native children, when parents are unable to care for them, should remain with other family members or other members of their Tribe. The case also spawned

debate over the custodial rights of a parent who previously gave up those rights.

In October 2012, the adoptive couple petitioned the Supreme Court of the United States to review the case. In January 2013, the court granted a review of the case and heard it in April. In June, the Supreme Court issued a 5-4 decision, holding that a non-custodial father did not have rights under the ICWA, and sent the case back to the South Carolina courts for further hearings on the issue. In July 2013, the South Carolina trial court finalized the adoption of the child to the adoptive couple, but this was prohibited in August by the Oklahoma Supreme Court. The stay was lifted in September 2013, and the child was turned over to her adoptive parents the same month.

You may or may not have noticed the effect federal budget sequestration had on federal Indian programs, but many people were writing and talking about it including many journalists who work for Native American owned publications. Sequestration refers to the across the board spending cuts that took place early last year. The FY 2013 sequestration began when Congress' Joint Select Committee on Deficit Reduction failed to develop a framework call for in the Budget Control Act of 2011 to reduce the nation's deficit by \$1.2 trillion.

While many federal programs were

impacted by the budget cuts, the cuts on federal Indian programs appear to have had a more direct impact on tribal communities with over \$500 million in program cuts. This included \$220 million cut to the Indian Health Service, \$33 million to the Native American Housing Block Grant, and \$12 million to Indian Head Start programs. There are some indications that the 2014 budget will include funding that will make up some of the cuts made in these programs. More so, the fight for federal budget dollars is ongoing.

On December 27, 2013 President Obama signed H.R. 2219, the Native American Veterans' Memorial Act of 2013. This Bill authorizes the construction of a new National Native American Veterans' Memorial on the property of the National Museum of the American Indian located at the National Mall in Washington D.C., along with several other museums and national monuments. There is a memorial for Native veterans now, but it is located inside the museum.

The signing of this Bill was a milestone in an ongoing effort to have a public site dedicated to Native American veterans. Native American veterans have been honored many times in many ways; I don't think anyone has questioned their service, but with all the memorials located at the National Mall, there is not one that recognizes the contributions of Native veterans (42,000 Native Americans served in Vietnam).

New \$9.84 Scam as Reported by the BBB



The Better Business Bureau is warning consumers ... be aware of a new credit card scam circulating where a recent charge of \$9.84 appears on your credit card statement from an unfamiliar website. Scammers are charging stolen credit card numbers a small amount of money in hopes cardholders will not notice the small charge and credit card companies won't go after the minor charge.



Check your credit card statements carefully. If you notice ANY unauthorized charges, promptly report the charges to your bank and request a new credit card. At this point, your credit card has been compromised and it is likely the scammers will charge again.

Identity theft occurs when someone uses your name, Social Security number, date of birth, or other identifying information, without permission, to commit fraud. Protect yourself, protect your money, and be aware of the warning signs of ID theft. If you spot a problem early, it is easier to remedy.

RED FLAG WARNINGS

1. You receive a bill for a purchase you did not make.
2. There are unauthorized charges on your monthly credit card statement.
3. You receive collection calls for goods or services you did not purchase.
4. You receive new credit cards or statements for accounts that you didn't open.
5. You don't receive your regular monthly bank or credit card statement in the mail (or email) as usual.
Someone may have changed your mailing address with your financial institution so fraudulent activity is not immediately detectible.
6. You receive an email acknowledging your change of address request WHICH YOU DID NOT MAKE.
7. You receive denials of credit for no apparent reason, e.g. a credit card or loan you did not apply for.

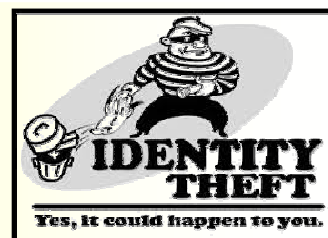

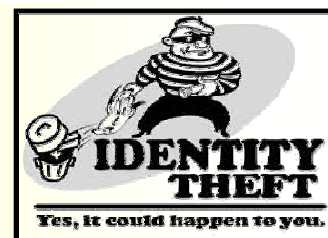

News from Indian Country: Three from 2013

This month's article will describe three 2013 news stories that impacted Native American communities.

As I've done with previous articles, each story will include a summary and web links for readers to learn more, if they so desire. I had thought of calling this article *The Best of 2013*, but it is more appropriate to title it *Three from 2013*.

These are stories that have been discussed for more than a year which address subjects (adoption of Native children, budget cuts to Indian programs, and honoring Native military veterans) that will continue to be discussed for a long time.

In 2009, a couple from South Carolina sought to adopt a child whose father, Dusten Brown, was an enrolled member of the Cherokee Nation and whose non-tribal mother had custody of the child per an agreement with Brown. Brown contested the adoption on the grounds that he was not properly notified in accordance with the federal Indian Child Welfare Act. He received custody of his daughter after winning cases in trial court and the South Carolina Supreme Court.

The case received extensive coverage in the national media, and spurred calls for Congress to review and make amendments to the 1978 Indian Child Welfare Act. Reflecting the intention of ICWA, the case also created discussion over why Native children, when parents are unable to care for them, should remain with other family members or other members of their Tribe. The case also spawned

debate over the custodial rights of a parent who previously gave up those rights.

In October 2012, the adoptive couple petitioned the Supreme Court of the United States to review the case. In January 2013, the court granted a review of the case and heard it in April. In June, the Supreme Court issued a 5-4 decision, holding that a non-custodial father did not have rights under the ICWA, and sent the case back to the South Carolina courts for further hearings on the issue. In July 2013, the South Carolina trial court finalized the adoption of the child to the adoptive couple, but this was prohibited in August by the Oklahoma Supreme Court. The stay was lifted in September 2013, and the child was turned over to her adoptive parents the same month.

You may or may not have noticed the effect federal budget sequestration had on federal Indian programs, but many people were writing and talking about it including many journalists who work for Native American owned publications. Sequestration refers to the across the board spending cuts that took place early last year. The FY 2013 sequestration began when Congress' Joint Select Committee on Deficit Reduction failed to develop a framework call for in the Budget Control Act of 2011 to reduce the nation's deficit by \$1.2 trillion.

While many federal programs were

impacted by the budget cuts, the cuts on federal Indian programs appear to have had a more direct impact on tribal communities with over \$500 million in program cuts. This included \$220 million cut to the Indian Health Service, \$33 million to the Native American Housing Block Grant, and \$12 million to Indian Head Start programs. There are some indications that the 2014 budget will include funding that will make up some of the cuts made in these programs. More so, the fight for federal budget dollars is ongoing.

On December 27, 2013 President Obama signed H.R. 2219, the Native American Veterans' Memorial Act of 2013. This Bill authorizes the construction of a new National Native American Veterans' Memorial on the property of the National Museum of the American Indian located at the National Mall in Washington D.C., along with several other museums and national monuments. There is a memorial for Native veterans now, but it is located inside the museum.

The signing of this Bill was a milestone in an ongoing effort to have a public site dedicated to Native American veterans. Native American veterans have been honored many times in many ways; I don't think anyone has questioned their service, but with all the memorials located at the National Mall, there is not one that recognizes the contributions of Native veterans (42,000 Native Americans served in Vietnam).

New \$9.84 Scam as Reported by the BBB



The Better Business Bureau is warning consumers ... be aware of a new credit card scam circulating where a recent charge of \$9.84 appears on your credit card statement from an unfamiliar website. Scammers are charging stolen credit card numbers a small amount of money in hopes cardholders will not notice the small charge and credit card companies won't go after the minor charge.



Check your credit card statements carefully. If you notice ANY unauthorized charges, promptly report the charges to your bank and request a new credit card. At this point, your credit card has been compromised and it is likely the scammers will charge again.

RED FLAG WARNINGS

1. You receive a bill for a purchase you did not make.
2. There are unauthorized charges on your monthly credit card statement.
3. You receive collection calls for goods or services you did not purchase.
4. You receive new credit cards or statements for accounts that you didn't open.
5. You don't receive your regular monthly bank or credit card statement in the mail (or email) as usual.
Someone may have changed your mailing address with your financial institution so fraudulent activity is not immediately detectible.
6. You receive an email acknowledging your change of address request WHICH YOU DID NOT MAKE.
7. You receive denials of credit for no apparent reason, e.g. a credit card or loan you did not apply for.

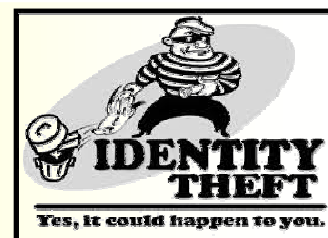
Follow up on ANYTHING that looks or feels out of the ordinary. ID thieves are skilled and cunning at their trade and expect complacency from their victims. **Do not be a victim.**

You may request your FREE credit reports annually from EQUIFAX, Experian, and TransUnion. **Be vigilant about checking your credit reports annually, or better yet, quarterly.** If you check one credit report per quarter, you have a better chance at identifying any fraudulent activity than if you check all three credit reports once annually.

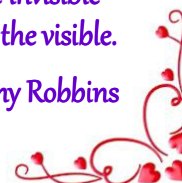

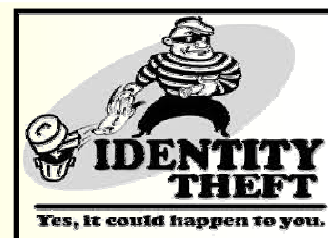

The largest Groundhog Day celebration is held in Punxsutawney, PA. It began as a Pennsylvania German custom in the 18th and 19th centuries and has its origins in ancient European weather lore.

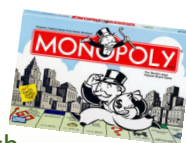

News from Indian Country: Three from 2013

This month's article will describe three 2013 news stories that impacted Native American communities.

As I've done with previous articles, each story will include a summary and web links for readers to learn more, if they so desire. I had thought of calling this article *The Best of 2013*, but it is more appropriate to title it *Three from 2013*.

These are stories that have been discussed for more than a year which address subjects (adoption of Native children, budget cuts to Indian programs, and honoring Native military veterans) that will continue to be discussed for a long time.

In 2009, a couple from South Carolina sought to adopt a child whose father, Dusten Brown, was an enrolled member of the Cherokee Nation and whose non-tribal mother had custody of the child per an agreement with Brown. Brown contested the adoption on the grounds that he was not properly notified in accordance with the federal Indian Child Welfare Act. He received custody of his daughter after winning cases in trial court and the South Carolina Supreme Court.

The case received extensive coverage in the national media, and spurred calls for Congress to review and make amendments to the 1978 Indian Child Welfare Act. Reflecting the intention of ICWA, the case also created discussion over why Native children, when parents are unable to care for them, should remain with other family members or other members of their Tribe. The case also spawned

debate over the custodial rights of a parent who previously gave up those rights.

In October 2012, the adoptive couple petitioned the Supreme Court of the United States to review the case. In January 2013, the court granted a review of the case and heard it in April. In June, the Supreme Court issued a 5-4 decision, holding that a non-custodial father did not have rights under the ICWA, and sent the case back to the South Carolina courts for further hearings on the issue. In July 2013, the South Carolina trial court finalized the adoption of the child to the adoptive couple, but this was prohibited in August by the Oklahoma Supreme Court. The stay was lifted in September 2013, and the child was turned over to her adoptive parents the same month.

You may or may not have noticed the effect federal budget sequestration had on federal Indian programs, but many people were writing and talking about it including many journalists who work for Native American owned publications. Sequestration refers to the across the board spending cuts that took place early last year. The FY 2013 sequestration began when Congress' Joint Select Committee on Deficit Reduction failed to develop a framework call for in the Budget Control Act of 2011 to reduce the nation's deficit by \$1.2 trillion.

While many federal programs were

impacted by the budget cuts, the cuts on federal Indian programs appear to have had a more direct impact on tribal communities with over \$500 million in program cuts. This included \$220 million cut to the Indian Health Service, \$33 million to the Native American Housing Block Grant, and \$12 million to Indian Head Start programs. There are some indications that the 2014 budget will include funding that will make up some of the cuts made in these programs. More so, the fight for federal budget dollars is ongoing.

3. Memorial for Native American Veterans of Military Service in Washington D.C.: <http://www.indianz.com/News/2013/012107.asp>

On December 27, 2013 President Obama signed H.R. 2219, the Native American Veterans' Memorial Act of 2013. This Bill authorizes the construction of a new National Native American Veterans' Memorial on the property of the National Museum of the American Indian located at the National Mall in Washington D.C., along with several other museums and national monuments. There is a memorial for Native veterans now, but it is located inside the museum.

The signing of this Bill was a milestone in an ongoing effort to have a public site dedicated to Native American veterans. Native American veterans have been honored many times in many ways; I don't think anyone has questioned their service, but with all the memorials located at the National Mall, there is not one that recognizes the contributions of Native veterans (42,000 Native Americans served in Vietnam).

New \$9.84 Scam as Reported by the BBB



The Better Business Bureau is warning consumers ... be aware of a new credit card scam circulating where a recent charge of \$9.84 appears on your credit card statement from an unfamiliar website. Scammers are charging stolen credit card numbers a small amount of money in hopes cardholders will not notice the small charge and credit card companies won't go after the minor charge.



Check your credit card statements carefully. If you notice ANY unauthorized charges, promptly report the charges to your bank and request a new credit card. At this point, your credit card has been compromised and it is likely the scammers will charge again.

Don't Be A Victim - Warning Signs of ID Theft

Identity theft occurs when someone uses your name, Social Security number, date of birth, or other identifying information, without permission, to commit fraud. Protect yourself, protect your money, and be aware of the warning signs of ID theft. If you spot a problem early, it is easier to remedy.

RED FLAG WARNINGS

1. You receive a bill for a purchase you did not make.
2. There are unauthorized charges on your monthly credit card statement.
3. You receive collection calls for goods or services you did not purchase.
4. You receive new credit cards or statements for accounts that you didn't open.
5. You don't receive your regular monthly bank or credit card statement in the mail (or email) as usual.
Someone may have changed your mailing address with your financial institution so fraudulent activity is not immediately detectible.
6. You receive an email acknowledging your change of address request WHICH YOU DID NOT MAKE.
7. You receive denials of credit for no apparent reason, e.g. a credit card or loan you did not apply for.

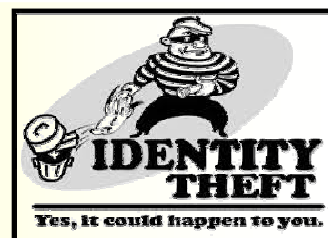
Follow up on ANYTHING that looks or feels out of the ordinary. ID thieves are skilled and cunning at their trade and expect complacency from their victims. **Do not be a victim.**

You may request your FREE credit reports annually from EQUIFAX, Experian, and TransUnion. **Be vigilant about checking your credit reports annually, or better yet, quarterly.** If you check one credit report per quarter, you have a better chance at identifying any fraudulent activity than if you check all three credit reports once annually.

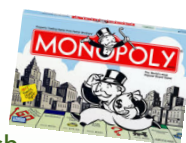

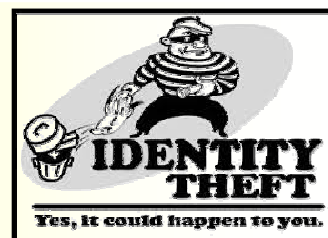
