CIHA Begins Phase 2 Operations of Reopening Plan

Over the past month, under its Phase 1 reopening plan, CIHA has restored staffing levels and modified internal processes to comply with CDC guidelines. As CIHA moves into Phase 2, necessary precautions are in place to safely resume other operations as well.

Initially, this will mean opening access to the office by appointment, scheduling deferred work orders, resuming

the lawn equipment lending program, performing exterior maintenance inspections and tasks, and similar work that can be accommodated by health screening, social distancing, sanitizing, wearing protective equipment, and other recommended practices.

For now, we continue to encourage the use of remote communications to the extent possible. Staff are

available by phone and email to assist with applications, income updates, scheduling work orders, and assisting with other needs.

CIHA hopes to offer additional electronic services soon.

CIHA is resuming loaning lawn equipment to residents. There are a few changes (noted below). If you have any questions, please contact CIHA.

- 1. Please call CIHA to schedule delivery of mowers and string trimmers.
- 2. Lawn equipment will be delivered within 24-48 hours depending upon equipment availability. You may keep the equipment for 24 hours.
- 3. Lawn equipment will be sanitized prior to delivery.
- 4. After a resident's use, lawn equipment will be picked up and thoroughly sanitized before it is loaned out again.

Coos Bay Farmers Market Is Open Every Wednesday 9 A.M - 2 P.M. through October 28th



The Coos Bay Farmers Market, located on Central Avenue between Highway 101 South and 4th Street in

Coos Bay, began its 20th season on June 3rd. The opening was delayed in response to Governor Brown's Executive Order.

In compliance with the Governor's Phase 1 reopening plan, CDC guidelines, and the Oregon Farmers Market Association (OFMA), the Market implemented new, required changes this year. All staff, volunteers, and vendors are required to wear face masks and gloves.

Vendors will have hand

sanitizer at their booths; the booths are placed at least 8 feet apart.

The Market is not intended as a social gathering place this year; Safety Greeters are located throughout the Market to encourage social distancing.

Hand washing stations, provided by Banner Bank, have been placed in the Market area. Shoppers may want to bring their own personal hand sanitizer to use. Market shoppers are asked to wear face masks and thoroughly wash their hands before coming to the Market.

They are encouraged to leave children and

of the household do the shopping (avoid bringing the whole family).

Shoppers are encouraged to be safe, shop quickly, and purchase only essential items.

Instructional signs at the Market read: "Shop with your Eyes". Shoppers may not handle products prior to purchase.

Food vendors will provide "Take Away" food only. Prepared food must be consumed off the Market premises.

The Market has special shopping hours for senior citizens and persons with underlying health conditions/issues; 9 A.M. to 10 A.M.

Remember to clean and wash all purchased produce at home before consuming.

Coquille Tribal Lands Fireworks Ordinance 650.620

Please remember as you celebrate this 4th of July, that while fireworks are fun and exciting, they can be a fire hazard and safety concern if not handled properly. Coquille Tribal Ordinance 650.620 states that "a person commits a fireworks violation if the person sells or uses fireworks within the lands of the Tribe, except as hereby provided:

 Only those fireworks allowed by the State of Oregon are approved for use on Tribal Lands. 2. Fireworks may only be ignited during the 48 hours before the official holiday and for 24 hours after.

 Official holidays during which fireworks may be ignited are the 4th of July and New Years Day.

 Any person under the age of eighteen must have the immediate supervision of an adult.

> Improper or unsafe use will result in the confiscation of all fireworks in the possession of the person by Tribal Police.

6. Tribal officials may make subsequent restrictions on the use of fireworks based on public safety, weather conditions, and fire concerns.

7. In addition, and not in lieu of any other penalty allowed by law, a \$50 assessment shall be paid to the Coquille Indian Housing Authority by any person found in violation of this ordinance."
