Low Income Home Energy Assistance Program (LIHEAP) Begins October 1, 2020 LIHEAP Helps Households Pay for Energy Costs

LIHEAP is a federal program that offers financial assistance to qualifying low income households to help pay energy costs, such as heat and electric bills. This assistance is provided through the Department of Health and Human Services. Both renters and homeowners are eligible for LIHEAP.

The amount of financial energy assistance a household is eligible directly to the energy provider.

to receive from LIHEAP is determined by household composition, household income, documented energy costs, and other factors in the current program year. Under federal law, to be eligible for LIHEAP, the household income must be at or below 60 percent of Oregon's median income.

APPLICATIONS HAVE NOT YET BEEN MAILED **OUT.** If you did NOT receive LIHEAP funding last year, or if your address has changed, contact Oregon Coast Community Action (ORCCA) at (541) 435-7082 or visit the office at 1855 Thomas Avenue (off of LaClair Street) in Coos Bay.

## Beware of Scammers Posing as COVID-19 Contact Tracers

Scammers, posing as COVID-19 contact tracers, are calling people to try and obtain credit card or bank account information. They may say, "you have been in contact with someone who has COVID-19" and they will typically ask for payment information "before we continue". They may also text or email you.

Contact tracers generally work for health departments. They contact COVID -positive patients to track symptoms, help patients figure out how to isolate themselves from others, and determine who they might have been near in the days just before or after they tested positive for COVID-19.

- \* Real contact tracers WILL NOT ask you for money.
- Contact tracing DOES NOT require your bank account or credit card number.
- Legitimate contact tracers will NEVER ask for your Social Security number.
  Do not give out any part of your number.
- Immigration status DOES NOT matter for contact tracing; real contact tracers won't ask.
- DO NOT click on a link in a text or email. Doing so can download malware onto your device.

Be discerning, but don't avoid real contact tracers. You need to know if you have been exposed to COVID-19 so that you can be proactive in isolating, getting tested, and letting other people you have been around know that you have been exposed.
