RESOLUTION CY24039

APPOINTING THREE MEMBERS TO THE COQUILLE INDIAN HOUSING AUTHORITY BOARD OF COMMISSIONERS

- WHEREAS, the Coquille Indian Tribe ("Tribe") is a federally recognized Indian tribe pursuant to the Coquille Indian Restoration Act of June 28, 1989, 25 U.S.C. § 715, et seq. ("the Act"); AND
- WHEREAS, the Coquille Indian Tribe is governed by the Coquille Tribal Council pursuant to the Tribal Constitution adopted by eligible voters of the Tribe on August 27, 1991, and approved by the Secretary of the Interior on September 9, 1991; and that the Tribal Council is empowered to act for the Coquille Indian Tribe; AND
- WHEREAS, the Tribal Council has adopted a Housing Ordinance establishing the Coquille Indian Housing Authority ("CIHA") and providing that CIHA would be governed by a Board of Commissioners, and that the Board is currently comprised of seven members; AND
- WHEREAS, due to expiring terms, there are three positions on the CIHA Board of Commissioners up for appointment, positions #2, #4, and #7 which are currently held by Denise Hunter, Judy Rocha, and Jackie Chambers; AND

WHEREAS, the Tribal Council wishes to appoint individuals to serve in these positions; NOW

THEREFORE, BE IT RESOLVED, that the Tribal Council appoints Denise Hunter to serve a three-year term on the CIHA Board of Commissioners in Position #2, which will expire April 30, 2027; AND

THEREFORE, BE IT FURTHER RESOLVED, that the Tribal Council appoints Judy Rocha to serve a three-year term on the CIHA Board of Commissioners in Position #4, which will expire April 30, 2027; AND

THEREFORE, BE IT FURTHER RESOLVED, that the Tribal Council appoints Jackie Chambers to serve a three-year term on the CIHA Board of Commissioners in Position #7, which will expire April 30, 2027; AND
